



Eurail One Country Pass – Czech Republic Pass 2010 歐洲單區火車證 – 捷克火車證 2010

Introduction 簡介：

- ✧ Unlimited travel on the national rail networks of Czech Republic.
- ✧ Pass valid for travel any 3, 4, 6, 8 days within 1 month.
- ✧ Travel days may be used consecutively or non-consecutively.
- ✧ List of bonus offer refer to travelers' guide.
- ✧ 有效期內無限次乘坐捷克火車。
- ✧ 火車證可選擇於一個月有效期內任何 3、4、6 或 8 日無限次乘坐火車。
- ✧ 在一個月內乘車日可以是連續或非連續使用。
- ✧ 優惠請參閱旅客指南。

Notes:

- ** Youth pass is valid for passenger aged 12-25 years on the 1st date of travel.
- Child aged 4-11 yrs on the 1st date of travel : Child fare.
- Child aged 0-3 years on the 1st date of travel & sharing seat/bed with adult : Free.

Terms & Conditions

1. **Eligibility** : People with a permanent residence (for more than 6 months) outside of Europe, the United Kingdom, Turkey, Morocco, Algeria, Tunisia or the Russian Federation are eligible to purchase or use Eurail Czech Republic Pass.
2. **Ticketing** : A non-refundable ticket issuing fee of **HK\$40 per person** will be applied.
3. **Seat Reservation** : Pass allows the boarding of a train or boat, but does NOT guarantee a seat. Seat reservations are optional for most trains but are mandatory for all premier trains, sleepers and couchettes. A non-refundable reservation fee applied if advance seat reservation required. Additional ticketing fee of HK\$40 per person per sector will be levied. Seat reservation is subject to availability.
4. **Validation** : Pass must be validated within 6 months of issue date and prior to board on the 1st train / enjoy the 1st bonus. Passport must be presented upon validation. All parties must be presented when validating the Saver Pass.
5. **Date Calculation** : Pass validity / Date calculation is from mid-night to mid-night & based on calendar month, except travelling on an overnight train that departs after 7pm. **7pm rule** (apply on flexi pass only): When travelling on a direct overnight train departing after 7pm, traveller should write down the next day's date on the pass.
6. **Bonus Offer** : Flexipass : enjoy a free passage on a ship requires to use a travel day and travel at reduced fares does not require use of a travel day.
7. **Refund** : Passes are refundable only if totally unused, unvalidated and returned within 1 year from the issue date. Refund charge : 15% cancellation fee of fare together with HK\$250 handling fee per ticket.
8. **Others** : Pass cannot be void once issued. Pass is non-refundable & no replacement if lost, stolen or partially used. Other terms & conditions applied. Prices & conditions are subject to change without prior notice.

條款及細則

1. **適用人士**：歐洲、英國、土耳其、摩洛哥、阿爾及利亞、突尼西亞及俄羅斯聯邦等國以外之永久居民(在當地定居越 6 個月)，才合資格購買或使用歐洲捷克火車證。
2. **出票**：出票手續費每位 **HK\$40**。手續費一經收取不作退還。
3. **預留座位**：火車證持有人獲准登火車或船，但並不保證有座位。除特級火車、臥舖及坐臥兩用車廂外，大部分火車都不須預留座位。如要預留座位，留位費將另行收取及不設退還。預留之座位須另繳出票手續費每位 **HK\$40**。預留座位受當時車廂情況所影響。
4. **確認火車證**：火車證須在出證後 6 個月內及首次登火車或享用優惠前，到火車站服務台出示火車證及護照作確認，方才生效。如使用慳錢火車證(Saver Pass)之人士，確認火車證時必須全員在場。
5. **日子計算**：火車證有效期或日期計算是由午夜十二時至翌日午夜十二時為一日，而月份依曆月計算。下午七時規定(只適用於彈性火車證)：若旅客如乘搭下午七時後發車之通宵火車，請於火車證的日期欄上填上翌日日期。
6. **優惠**：彈性火車證持有人：若享用免費船程優惠，須扣一可乘車日。若享用折扣優惠則無須扣減可乘車日。
7. **退款**：退款申請只適用於完全没有使用、未經確認的火車證，並於出證後一年內交回方可申請退款。退款費用：火車證價錢的 15% 作取消罰款，另加每張 **HK\$250** 手續費。
8. **其他事項**：若火車證遺失或被盜，將不會重發或退款。火車證出證後，不能註銷。附有其他條款。價格若有任何更改，不會另行通知。
